## Divisions *Individual Registrations*

### 18 & Over Gold(Advanced) and Silver(Novice)

- Two Divisions - Gold and Silver
- Season runs from early October through mid April
- 20 Games plus playoffs. Games played on weeknights, Monday through Thursday evenings
- Jerseys provided for all players
- **Deadline to register:** September 15
- **Registration Fees:** \$325 per player (\$200 due at registration; \$125 due by Oct. 31) If paying with credit card, 325 payment must be made in full
- Goaltenders - \$50, and must complete a registration form
- \$50 discount if you play for two teams

Pay your \$35 USA Hockey Individual Membership Registration (IMR) online at **usahockeyregistration.com**. Then bring your confirmation receipt to the league director at Suburban Ice-East Lansing with your registration form.

## League Features

- Players must sign in before all games
- Players must have registration form and USA Hockey Confirmation on first game day to receive a jersey
- All games played at Suburban Ice - East Lansing
- Games consist of three 16-minute running-time periods
- No-checking league
- Focus on fun and even competition
- Strict enforcement of rules

- Trained scorekeepers and officials included in league fees
- All participants will be required to sign a release of liability waiver

## League Format

- Players are assigned to teams by the arena, with the objective of having all teams be equal strength. Players may request to be on the same team as three other players, however Suburban Ice-East Lansing cannot guarantee all requests will be honored and all teams are subject to trades during the season to maintain balance.
- If necessary after one round of games, teams will be divided into two conferences – upper and lower – to ensure a strong competitive level throughout the year. Suburban Ice - East Lansing reserves the right to move teams to the proper level if their caliber of play is inappropriate to the standard of the league entered.

### Waiver & Release

In consideration of my enrollment and participation in a Suburban Sports Group program, I hereby release and discharge Suburban Sports Group and Suburban Ice-East Lansing (hereinafter referred to as "SIEL") together with their agents, employees, officers, owners, sponsors, volunteers and all other participants forward on behalf of myself, my children, my parents, my heirs and assigns as follows:

1. I acknowledge that the sport of hockey involves known and unknown risks which could result in physical or emotional injury, paralysis, death, or damage to participants, to myself, to property or to third parties and that such risks simply cannot be eliminated. To that end, I further acknowledge that SIEL is not responsible for a participant's fitness, abilities or the equipment being used.
2. I acknowledge and agree to accept and assume any and all of the risks attendant to this activity. My participation in this activity is purely voluntary and I elect to participate notwithstanding the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless SIEL from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity or my use of SIEL equipment or facilities whether "on" or "off" the ice and, including any claims which allege negligent acts or omissions on the part of SIEL.
4. In the event SIEL, or anyone acting on their behalf is required to incur attorney's fees and costs to enforce this Agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance coverage for any injury or damage I may cause or suffer while participating, and I agree to bear any and all costs of such injury or damage. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, and I am willing to assume all risks and costs that may result, directly or indirectly, from any such condition.
6. I acknowledge that during the course of participation, SIEL may take photographs, audio recordings and/or video recordings of me. I hereby grant SIEL permission to use any and all such photographs or audio or video recordings of me for advertising, promotional or educational purposes. Such use may include publication in programs, advertising, posters, flyers, radio, television or other methods, and may be seen or heard by large numbers of individuals, including potential customers of Suburban. Participant waives all rights to any financial remuneration of any such use.

By signing this Document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I have waived my rights to maintain a lawsuit against SIEL.

I have had sufficient opportunity to read this entire document. I understand it and I agree to be bound by its terms.

In consideration of being permitted by SIEL to enroll and participate in its activities and to use its equipment and facilities, I have acknowledged and executed the foregoing Enrollment Agreement and Release.
